Smoke control systems shall be tested by a special inspector. **IFC 909.18.8**

Inspection and periodic testing of existing smoke control systems shall be performed in accordance with the Southern Nevada Fire Code Committee's - *Uniform Guideline for Smoke Control Testing & Recertification*, and the manufacturer's instructions. **IFC 909.20**

The Southern Nevada Fire Code Committee will maintain a list of approved Special Inspectors. **Guideline pp2 Definitions.**
